Honorable Secretary of the Senate:

Please find enclosed the Statement of Organization for a campaign committee for Friends of Karen Testerman, now in an exploratory committee status, considering a run for United States Senate in the 2014 election from the State of New Hampshire.

As Treasurer, I note that the Federal Election Commission does not have a procedure for notifying the FEC of an exploratory committee or exploratory effort.

Yet, out of an abundance of caution, given risks of appearing to lack full compliance and the importance of appearances, I now establish a Committee, notifying the FEC of the Treasurer information, and asking for an FEC Identification Number.

In addition, as Treasurer, I wish to be able to obtain the FEC's campaign finance compliance software by registering a campaign Committee.

Karen Testerman is not declaring herself as a candidate at this time but will explore the possibility of becoming a candidate and will make a formal decision later.
