Lorillard, Inc. (parent company of Lorillard Tobacco Company) began trading as an independent public company on June 10, 2008. Prior to that time, Lorillard, Inc. was a wholly owned subsidiary of Loews Corporation. In January of 2002, Loews issued a tracking stock known as the Carolina Group that traded on the New York Stock Exchange as CG. This issue was intended to track the performance of Lorillard, Inc. and certain related assets. As part of a series of transactions, CG shares were redeemed for Lorillard, Inc. shares and the remaining shares still owned by Loews were distributed to Loews shareholders in exchange for Loews common stock. As a result, Lorillard Inc. is no longer affiliated with the following committees: 1. CNA Financial Corporation Citizens for Good Government 2. Loews Corporation Public Affairs Committee
