Ms. Legge briefly explored a candidacy for Florida's 14th Congressional District. Contributions received on her behalf first exceeded \$5,000 on or about June 10, 2026. On June 12, 2026, before the fifteen-day period for filing under 11 CFR 101.1(a) had elapsed, Ms. Legge withdrew from the race. The Committee's remaining disbursements are limited to satisfying obligations incurred during the campaign and winding down its affairs. This Statement of Candidacy is filed in response to the Commission's letter dated July 19, 2026. The Committee intends to refund any remaining balance to contributors and to file its 2026 October Quarterly Report as its termination report.
