Form 99 language to implement settlement

The 2016 Committee was incorporated on March 9, 2015, was active through the 2016 election cycle, and has been inoperative for a long period. The 2016 Committee engaged in activities including direct mail, to raise funds, to identify supporters, and to promote certain presidential candidates. In its FEC reports, the Committee endeavored to distinguish between direct mail expenses which were properly organizational and fund raising in nature (on Schedule B), and those direct mail expenses which met the technical definition of independent expenditures (on Schedule E). In November 2017, the FEC selected The 2016 Committee for an audit. The FEC audit staff found no recordkeeping problems, but took the position that there were 11 disbursements totaling \$402,864.70 that were reported by the Committee on Schedule B which should have been reported on Schedule E, and that 14 other disbursements totaling \$697,014.64 were late-filed independent expenditures. The audit was referred to the Alternative Dispute Resolution ("ADR") process, which resulted in a negotiated settlement agreement for payment of a penalty and filing this clarifying Form 99, that was ultimately approved by the FEC. Although The 2016 Committee did not concede that its 25 disbursements were erroneously reported, it agreed that the following disbursements would be reported on Schedule E as independent expendent expendent.
