Dear Ms. Davis:

On behalf of my clients, Yamanouchi Consumer Inc. PAC and Bear Creek Corporation PAC (ID # C00401729), I am responding to your letter of June 16, 2004. In that letter, you requested information concerning the connected organization for the Yamanouchi Consumer Inc. PAC. As we discussed in our telephone conversation, there have been some recent developments affecting both of these PACs.

On October 31, 2000, Shaklee Corporation, which owned Bear Creek Corporation ("Bear Creek"), changed its name to Yamanouchi Consumer Inc. ("YCI"), and, effective April 1, 2001, transferred all its assets and employees relating to the Shaklee business to a newly-formed subsidiary named Shaklee Corporation. At the time of this reorganization, both Bear Creek Corporation and Shaklee had PACs registered with the Federal Election Commission. In 2003, YCI assumed responsibility for the administrative expenses of both PACs and decided that it would be more efficient to consolidate the PAC operations. Accordingly, on July 3, 2003, an amended Statement of Organization was filed for the Bear Creek Corporation PAC, changing its name to Yamanouchi Consumer Inc. PAC ("YCI PAC"). At that time, the Statement of Organization should have indicated that YCI was the connected organization. The Shaklee Corporation Good Government Fund (ID # C00126805), which was relatively inactive, was terminated and its remaining funds were transferred to the YCI PAC.

On June 17, 2004, YCI transferred ownership of Bear Creek Corporation to Wasserstein & Co. LP. In anticipation of this event, Bear Creek Corporation established a new PAC,

the Bear Creek Corporation PAC, effective May 26, 2004 by filing a Statement of Organization on June 2, 2004. The Statement of Organization indicated that Bear Creek is the connected organization and YCI PAC an affiliated committee. Since most of the contributions to YCI PAC were made by Bear Creek employees, all but \$250 of the funds then held by YCI PAC were transferred to the new Bear Creek PAC.

Since YCI no longer owns Bear Creek, Bear Creek PAC has filed an amended Statement of Organization (copy enclosed) to indicate that it is no longer affiliated with YCI PAC. In addition, I understand that the decision has been made to terminate the YCI PAC in the near future.

Enclosed is an amendment to the Statement of Organization for the YCI PAC indicating that YCI is the connected organization. Please do not hesitate to contact me if you have any questions about this letter.
