JOINT FUNDRAISING AGREEMENT

PURPOSE

The following is an Agreement between the Chenoweth for Congress Committee ("CFC") and the Simpson for Congress Committee ("SFC") pursuant to I.C.F.R. §102.17(c)(1). This agreement is entered into for the purpose of jointly holding a political fund-raising event to assist with the congressional candidacies of Representative Helen Chenoweth and State Senator Mike Simpson.

FUND-RAISING REPRESENTATIVE

CFC and SFC agree that, for purposes of this joint fund-raising event, the newly-formed Idahoans For A Republican Congress Committee ("IFRCC") shall serve as the fund-raising representative. IFRCC will establish a separate bank account to process joint fund-raising receipts and disbursements.

ALLOCATION OF PROCEEDS AND EXPENSES

CFC and SFC agree to split all costs and receipts evenly and equally (50%/50%).

COMPLIANCE WITH FEDERAL ELECTION LAWS


IFRCC has registered and will report with the Federal Election Commission. IFRCC will screen contributions to make sure they comply with the limits and prohibitions of the Federal Election Campaign Act. IFRCC will retain this agreement and preserve and maintain written records relating to this fund-raising event for three years.


CFC and SFC agree to amend their Statements of Organization and Statements of Candidacy to reflect the existence of this new authorized joint fund-raising committee.
