The enclosed letter from Porter for Congress to Judy's Letter & Secretarial Service sets forth the facts of the original transaction from March 1996.

I did not report the expenditure on our FEC report for the period, or show the balance claimed by Judy's as a debt of the Committee at that time because the Code of Federal Regulation - Federal Elections, as of January 1, 1996, Sec 100.8 (a) (1), defines expenditure as "a purchase of anything of value," and Sec 116.10 (a) requires reporting of a disputed debt "if the creditor has provided anything of value." I did not and do not agree that Judy's provided us with anything of value.

However, on June 24, 1997, I unexpectedly received correspondence from Judy's threatening legal action and an active campaign of negative publicity.

After consulting with the Congressman, we agreed that it would be too expensive to allow this matter to come into court, and I have now negotiated a settlement with Judy's and have offered them a \$1,600.00 payment to close the matter.

Porter For Congress is in receipt of an invoice from Judy's Letter & Secretarial Service, Inc. requesting payment of \$2,977.43. This letter is to inform you that Porter For Congress does not intend to pay this invoice.

You were clearly and directly informed that Porter For Congress wished to retain your services in order to fold, insert, seal, imprint with First Class 32¢ postage and deliver to the U.S. Postal Service (USPS) a mailing of approximately 14,000 pieces. You were further informed that the mailing pertained to the March 19th Illinois Primary Election and had to be received by addressees prior to March 18th, 1996. You acknowledged your understanding of these requirements, and you agreed and promised to perform these services in a manner that would result in all addressees receiving this First Class mailing on or prior to March 18th, 1996.

At approximately 7:00 a.m. on March 11th, 1996, the letters and envelopes for this mailing were delivered to Judy's Letter & Secretarial Service, Inc. by a representative of Porter For Congress, at which time it was reaffirmed to Judy's personnel that the mailing was extremely time-sensitive and that First Class 32¢ metered postage was to be used. When you were directly contacted by phone later that day, you confirmed receipt of these materials and again acknowledged your understanding that the mailing was time-sensitive and was to be sent using First Class 32¢ metered postage. At that time, you represented to Porter For Congress that the mailing would be completed in accordance with these instructions and would be delivered to the USPS no later than Tuesday, March 12th.

When we contacted you later that same week because none of the intended addressees had received the mailing, you contradicted your previous statement and said instead that the mailing had been delivered to the USPS on March 14th with First Class 32¢ metered postage affixed. We then requested a copy of the postal manifest to substantiate your claim.

You did not provide this information, and Porter For Congress subsequently obtained a copy of said manifest directly from the USPS. This document indicates clearly that the mailing was accepted by the USPS at 1:04 p.m. on March 18th, 1996. Obviously, the mailing was not

received at addressee households on or prior to March 18th. The document further indicates that the mailing was sent via Bulk Rate, 16.80 postage, not the First Class 320 postage you had promised would be used. Finally, the document appears to us to reflect an attempt to alter or otherwise misrepresent the date on which it was submitted to the USPS. Regardless, as mentioned above, the manifest clearly shows that the mailing was accepted late on March 18th, four full days after the date you claimed it was delivered to the USPS.

We feel that it is clear beyond any serious debate that you failed to perform the services for which Porter For Congress contracted and that your non-performance constitutes a material and total breach of contract on your part. Because of your non-performance, Porter For Congress received absolutely none of the benefit or value for which it had bargained. An election mailing delivered on or after election day is, quite simply, worthless, a fact of which you were well aware.

Porter For Congress has suffered additional foreseeable consequential damages as a result of your non-performance, including but not limited to approximately \$3,000 in costs associated with printing the letters and envelopes for this mailing.

It is our expectation and hope that you will regard this matter as closed and not pursue payment of the invoice. Please be advised, however, that should you continue to demand payment, Porter For Congress will not only adhere to our position as stated herein that no payment is due, but we will also pursue recovery of damages suffered as a result of your breach and take such other actions related to this matter as we determine to be necessary and appropriate.
