Dear Jan:

First of all, thank you for all your help and assistance in helping me administer our PAC over the last two years. Your input has been of great value.

As we have recently discussed, we wish to change the connected organization of our existing PAC (FEC I.D. #C00239962) from the Farm Credit Bank of Texas (see attachment #1) to the Tenth District Farm Credit Council, Inc. (see FEC Form 1). Since the Tenth District Farm Credit Council, Inc. is our trade association that is involved in our legislative efforts, it only seems logical that it be the connected organization for our PAC. The Board of Directors of the Tenth District Farm Credit Council, Inc. met on Wednesday, August 16, 1995 and unanimously voted to make this change.

As I understand our conversations, we need to:

1. File a new statement of organization (attached)
2. Open a bank account for our new PAC
3. Terminate the old PAC - as we discussed, our bank account balance for the old PAC will be less than \$10,000 after pending disbursements are made. \$5,000 will transferred from the old PAC to the new PAC in calendar year 1995 with the balance (less than \$5,000) to be transferred in calendar year 1996. After the bank account balance is down to zero in the old PAC, it can then be terminated.

Please review our "plan" and advise me if we are proceeding correctly. I shall look forward to hearing from you in the near future.
