This amendment is filed in response to the Commission's letter dated June 13, 2008. Regarding the issue outlined in #1 of the letter, the discrepancy in Column A and Column B totals was previously corrected through an amendment filed to the April 20th report on June 6, 2008. In response to the issues outlined in #2 and #3, the memo entry of 21st Century PAC's contribution has been removed. It is correct that no contribution to Buck McKeon for Congress was previously reported since the Committee had not made a contribution to that Committee. Instead, the Committee made a contribution to the 21st Century PAC on 3/24/08 which was mistakenly deposited by the Buck McKeon for Congress Committee. When the Buck McKeon for Congress Committee discovered its error it refunded the mistakenly deposited contribution to the ABC PAC. We have shown that refund in the best manner possible given that the forms do not contemplate this situation. In response to issue #4, the Commission's letter suggests that the contribution to Ozinga for Congress was made after the primary. However, the actual date of the primary was 4/30/08 and thus the contribution was appropriately designated. In response to issue #5, memo text has been added for the Schedule E disbursements.
