
Dear Ms. deBeau:

Please find attached an amendment to the October Quarterly Report and the Year End Report for FEC ID#C00308338. In your letter dated February 2, 1999, you noted two items. In response to those items, please consider the following:

- Line 11(b) from the prior report included no amount, but \$1,000 was included on line 11(e). This amount was applicable to line 11(b), but not included as there was no activity reported during the applicable period on that line. Once considering this, Column B for the report in question agrees to the sum of column A plus column B from the prior report.
- I have adjusted the amount \$13,407 to \$14,907 on the summary page. This results in an amendment to the year end report to show a debt of \$1,500 outstanding at the end of that period. I have adjusted both reports and attached them herein as amendments.
