This contract represents my proposal to serve as Assistant Treasurer for the Howard Kaloogian for U.S. Senate campaign committee.

As Asst. Treasurer, I will oversee all compliance and reporting services including all facets of financial record keeping, bank reconciliation and required FEC reports and documentation. I will perform the aforementioned functions and any other peripheral bookkeeping and accounting services required by the campaign.

A start up fee of \$1000 is required to open the bank account and prepare beginning paperwork. A minimum monthly retainer of \$2000 will be paid for 25 hours of service. After the monthly retainer hours are reached, \$85/hr will be charged for all time expended for bookkeeping, compliance and consulting services. The monthly retainer includes a reasonable amount of phone, fax, copies and mileage. In addition, a monthly fee of \$150 will be due for electronic filing software vendor, NetFile.

As the campaign volume increases, the above monthly retainer will be renegotiated to best benefit the campaign.
