With respect to the subject federal PAC contribution – CGI Technologies & Solutions Inc PAC (C00354241) - the committee has reviewed the related transaction and relevant materials and concluded that the contribution was appropriately processed and reported. Please be informed that in 2017, the committee established two bank accounts that were designated for political activity; one account was a federal account (NJDCS Victory Federal 2017), and one was a non-federal account (NJDCS Victory Non-Federal 2017). Activity related to the federal account was included with the committee's reports to the FEC. Activity related to the non-federal account was included with the committee's reports to the New Jersey Election Law Enforcement Commission (ELEC). The subject contribution was written to the committee's federal account (i.e., NJDCS Victory Federal 2017) and deposited to the designated account. 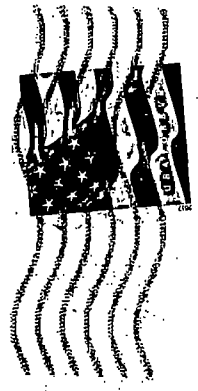

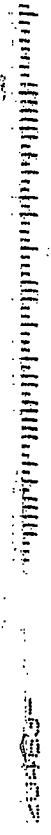
