Commonly 'year end expenditures' in the business world would mean a report that summarizes a year's worth of activity, but in this instance it covers only the fourth quarter of the year. The reason this matters is because I attempted to make the end of year report cumulative back to the formation of the committee. This is neither asked for nor allowed in FEC File but it accounts for most of my difficulties. Our July 15 Quarterly report covers the period of our founding on 5/6/22 to the end of the reporting period on 7/15/22. In this ten week period the committee had no activities and no transactions. It had no receipts, no disbursements, no loans, no debts. It did not solicit funds or receive them. It engaged in no external communications, no outreach and no recruitment. This lack of activity is reflected in the report, which has no data, reflecting no reportable activity
