

Dear Ms. Weintraub:

Effective immediately, I resign as the treasurer for the Jesse Jackson Jr. for Congress committee. As indicated, in my correspondence dated May 11, 2013 to the Federal Election Commission, I have no direct contact with the campaign account, I have no knowledge of the monies in the account, and I have no cancelled checks evidencing any expenditures from the account. I have never signed a campaign committee check and have had no access to campaign committee checks. Because I have never had a role in the preparation of the reports, these documents were *never* in my possession. It is impossible for me to prepare *any* campaign committee report. I have no contact with any individual who prepared reports in the past, nor do I have a copy of any reports previously prepared. There is no current official in office, nor campaign staff in existence to facilitate the preparation of any campaign report. You have consistently indicated in your correspondence to me, the address of "P.O. Box 490286, Chicago, IL 60649" as the address for Jesse Jackson Jr. for Congress campaign office. The address for the campaign committee was *never* my office. I have no knowledge where P.O. Box 490286 is located, nor do I have access to that post office box. There is no possibility whatsoever nor will there ever been a possibility that I could file any report for this committee. To do so, would involve conjecture and perjury and I refuse to engage in either activity.

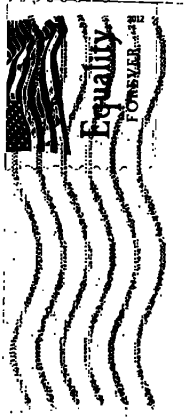


