Per the Form 99 filed on January 9, 2017, we made this change because, as a result of internal organizational changes effected on January 1, 2017, personnel exercising control of the PAC moved from JPMC to JPMCH. As discussed with the Commission staff prior to effecting such changes, the PAC name remains unchanged because our parent company, JPMC, remains the PAC's establishing and primary sponsoring connected organization.
