10/21/10 - We received a corporate check in error, from Planned Parenthood, for \$1000. Unfortunately I didn't realize it was a corporate check until I started filing this report. Today I spoke to James, one of the analysts at the FEC, and he asked me to write a note here explaining the situation. We deposited this check and disbursed it. It was NOT earmarked for a specific candidate by the corporation, we accepted it at a fundraiser with about 35 other checks, most of which were deposited in our state account. Because we disbursed a check from the federal account to a candidate, there is not currently enough money in the federal account to pay the check back to Planned Parenthood. But James said we have 45 days to make sure the funds are returned to Planned Parenthood. We will raise money to get the amount needed into the account and then we will make a refund as soon as possible (and by all means before the 45 days from the day it was deposited, which was October 12). This will be reflected on our next report, the post-general report which is due December 2. Please call me if you need further information. I am the independent contractor who does administrative work for the PAC, Amanda Narvaes, 616-334-6546. You could also call the Treasurer, Stacy Van Dyken, who also knows about the matter.
