The Committee includes a clear and conspicuous statement requesting the required donor information in every solicitation it does. It also includes language informing donors that federal law requires the Committee to request such information from anyone who contributes more than \$200 annually. If a contribution is received without it, a written request for the information is mailed within 30 days informing donors that federal law requires the Committee to follow-up and request this donor information from them. We also include in the follow-up request a pre-addressed return envelope. Also, no solicitation for additional funds is made in any best efforts letters that the Committee sends out. Any contributor information received as a result of the Committee's best efforts is reported to the Commission either in an amended report or on the next report it files.
