1. Regarding transfers from "COLORADO REPUBLICAN COMMITTEE" which has not been disclosed on their report(s) of receipts and disbursements. We have confirmed that we received funds from "COLORADO REPUBLICAN COMMITTEE". No further action is required.
2. Regarding Schedule A that discloses one or more contributions which appears to be from a corporation(s). The contribution from "GOOD STUFF LLC" was a result of a distribution from a joint fundraising committee that has since been refunded and will be reflected in the next distribution we receive from the joint fundraising committee. All other entities listed are not corporations and the Amended 30 Day Post General Report has been amended to include the attributions.
3. Regarding contributions in excess of limits pertaining to the Headquarters account. The identified excess contributions from Mr. Peyerk was a result of a distribution from a joint fundraising committee. An adjustment was requested in May 2021 that will result in the return of the contribution to the joint fundraising committee and will be reflected in the next distribution we receive from the joint fundraising committee. No additional information is required.
4. Regarding contributions in excess of limits pertaining to the Legal Proceedings account. The identified excess contributions from "WOLFCAP TEAM LLC" and their attribution Mr. Link was a result of a distribution from a joint fundraising committee. An adjustment was requested in May 2021 that will result in the return of the contribution to the join fundraising committee and will be reflected in the next distribution we receive from the joint fundraising committee. No additional information is required.
5. Regarding itemized disbursements using the description of "ENTERTAINMENT SERVICES". The Amended 30 Day Post General Report has been amended to use the purpose of "MUSICAL ENTERTAINMENT".
6. Regarding the coordinated expenditures on behalf of "TRUMP, DONALD J," which appear to have been made after the general election date, in each instance the RNC accepted a request by the Donald J Trump campaign to make such expenditure in the same period in which the RNC reported the expenditure. Each expenditure was reported accordingly; thus, no further action is required.
