I am in receipt of your letters dated November 21, 2000 regarding the Pete King for Congress 12 Day Pre-Primary Report & the 12 Day Pre-Primary Amended Report (7/1/00- 8/23/00).

I will address each question you have raised:

Due to unforeseen computer error there was a discrepancy in the Year-to-Date Total Contributions. I have corrected the Summary Page and Detailed Summary Page to the correct amounts.

Regarding the Schedule A - I have enclosed a partnership allocation from Seward & Kissel, LLP and amended the report to reflect the information for Morici & Morici, LLP. The procedure used for obtaining information on contributors is as follows:

- 1) Every contribution request contains the FEC disclaimer not only on our letterhead but also on the information request card, example enclosed.
- 2) A contributor who provides a contribution without the necessary information is sent a letter requesting that information.
- 3) Once that information is received, it is added to the report.

The report has been amended to reflect that missing information on the Schedule B that has now been obtained.

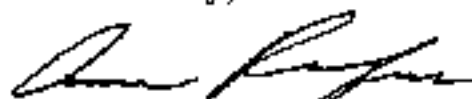

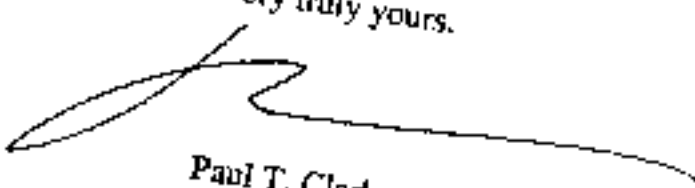
