This letter is prompted by the Commission's preliminary review of the report(s) referenced above. Please be advised that a lobbyist/registrant PAC is a political committee that is established or controlled by a lobbyist or registrant. (11 CFR §104.22(a)(3))

If your committee is a lobbyist/registrant PAC, please amend your Statement of Organization to check the Lobbyist/Registrant box on Line 5(e). Please amend your Statement of Organization to clarify your committee type or provide additional information regarding this discrepancy.

2. Please clarify your relationship, if any, with "AMERICAN BANKERS ASSOCIATION BANKPAC," which appears to be an affiliated committee. If your committee is affiliated with "AMERICAN BANKERS ASSOCIATION BANKPAC," you should amend your Statement of Organization to check the "Affiliated Committee" box on Line 6. to disclose the correct name and check the "Connected Organization" box on Line 6. (11 CFR §100.6)

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
