
In our telephone conversation today, you outlined some information that I need to submit in order to terminate the Jo Ann Howard for Congress Campaign Committee established in either late 1995 or 1996 (the primary was in 1996) in my unsuccessful race for Congress. **Please accept this correspondence as a termination letter.**

My late husband, Ed Howard, was treasurer for my congressional committee, but sadly, he died in July 1998. Thus, I must by default be the contact person to terminate this election committee. My permanent address is P.O. Box 160130, Austin, Texas, phone 512-328-8444.

I am attaching a copy of verification from Commercial National Bank of Texarkana, Texas that all loans to my campaign by me were forgiven and no loans remain. The account was closed some time ago. I served as an appointee to FEMA from 1998-2001 and was not living in Austin, Texas or Texarkana, Texas during that period.

No monies have come into or gone out of the Commercial National account for several years. As I told you, I made a trip over to the FEC in the 1998-99 period and sat down with two staffers and understood this matter was completely closed. I hope that you will confirm that this letter and bank information will accomplish that. It's been way too long to continue to correspond about a political race that is over seven years old. Thank you for your assistance.
