It was a pleasure speaking with you this morning. Thank you for your assistance in this matter.

As I said on the telephone, our April 21, 1999, filing of FEC Forms 1 and 2 were apparently in error. While we intended to create a new campaign committee for the 2000 congressional campaign, our efforts were instead interpreted as continuing our old campaign committee. We request that you assign us a new committee ID number that we can use for the 2000 election.


We have been raising money for the 2000 election under the impression that a new committee had been formed. It has been kept in separate bank accounts from the 1998 campaign's funds. All funds we have received are intended for the 2000 election.
