Dear Ms. Denny, Mr. Maxwell and Mr. Gibson:

This letter responds to your letters of:

- March 8 and March 30, 2000, regarding the AMI Political Action Committee (AMI-PAC) 1999 year-end report; and
- May 8, May 10, July 19, August 17 and November 30, 2000, regarding the AMI-PAC 2000 first quarter report; and
- November 8, 2000, regarding the AMI-PAC 2000 second quarter report.

I apologize for such a late response to your many letters, but I never saw them. It appears that a former staff assistant hid all FEC correspondence from me in an effort to conceal his errors in filing accurate and timely AMI-PAC FEC reports. It was only after I received a fax from FEC on November 17 - a day this staff assistant was out of the office and could not intercept the fax - that I realized we had problems. I subsequently retrieved the correspondence referenced above from the FEC website.

Regarding the 1999 year-end report, we had incorrectly reported \$6,000.00 in expenditures as PAC refunds, or income, on line 28-c. Enclosed is an amended 1999 year-end report, showing these expenditures totaling \$6,000.00 -- one for \$1,000.00 on September 9, 1999 to Crane for Congress and one for \$5,000.00 on September 9, 1999 to the New Democratic Network. All other figures have been corrected and revised on this amended report.

Regarding the 2000 first quarter report, we again incorrectly reported \$20,000.00 in expenditures as PAC refunds, or income, on line 28-c. Enclosed is an amended report. Please note that our original Schedule B accurately listed this \$20,000.00 as expenditures (\$5,000.00 on March 6, 2000, to the Blue Dog PAC, and \$15,000.00 on March 29, 2000 to the Republican House/Senate Dinner). We have enclosed an amended 2000 first quarter report.


Regarding the 2000 second quarter report, we incorrectly reported July 12, 2000, expenditures of \$4,000 to the Bush-Cheney for President general election fund and \$4,000 to the Bush-Cheney for President primary fund. Enclosed is an amended 2000 second quarter report. Please note that the July 12 expenditures were made to the Bush-Cheney for President primary fund for \$4,000 and to the Bush-Cheney General Election Legal Compliance Committee (GELAC) for \$4,000. No funds were expended for the Bush-Cheney for President general election effort.

Also regarding the 2000 second quarter report, the entry on line 28(c) mistakenly reflected refunds made from other Political Committees, rather than contributions. We have corrected that information on the amended report. In addition, we have made our best efforts to provide all information of individuals that contributed in excess of \$200 in the calendar year. You will note that those individuals whose addresses were omitted worked for Taylor Packing Company. All dates that were omitted or incorrect are now correct, and we have provided information regarding the elected office sought, including state and congressional district, to amend Schedule B supporting line 23.

Because of the corrections made to preceding reports, we are also filing an amended 2000 third quarter report, as well as our pre-general election and post-general election reports. All reports should now be correct.
