Dear Ms. Mongeon:

This statement is in response to the Commission's letter to the Committee dated November 5, 2017, regarding three items.

First, the Commission's letter requests clarification on contributions from 94 contributors that appear to exceed federal contribution limits. As described below, all of those contributions were properly redesignated, reattributed, refunded, or charged back, as will be reflected on either the Amended October Quarterly Report being filed concurrently with this response or the Committee's upcoming 2017 Year End Report:

- Forty-two of the listed contributors' contributions were redesignated to another election.
- One contributor's contribution(s) was reattributed to the contributor's spouse while the remainder was refunded.
- One contributor's contribution was redesignated to another election in part while the remainder was refunded.
- Three contributors' contributions were either refunded or charged back to the contributor's credit card.
- Forty-three contributors had contributed to the Committee but subsequently made additional contributions to either Trump Victory (C00618389) or Trump Make America Great Again Committee (C00618371) - joint fundraising committees ("JFCs") in which the Committee participates - which transferred the contributions to the Committee. Any excessive contributions that resulted from contributions received by the Committee through the JFCs have been returned to the JFCs for proper reallocation among its participants. (The reallocations will be disclosed by the JFCs on the appropriate report.)
- Finally, four contributors' contributions were both in part redesignated to another election and either refunded or returned to and reallocated by the JFC from which the contribution was received.

Second, regarding the credit card disbursement referenced in the Commission's letter, the Committee included the memo itemization for that disbursement, but due to a clerical error, referenced the wrong transaction ID number for those entries. The Committee has corrected the transaction ID number for the relevant entries in the Amended report being filed concurrently with this response.
