Dear Mr. Bonior:

This letter constitutes formal written notification that Bonior for Congress is filing reports of receipts and disbursements (FEC FORM 3) that appear to be for the 2002 election.

A review of these reports indicates that your principal campaign committee has no debts from the previous election cycle, and has accepted contributions and/or made expenditures in support of your 2002 candidacy in excess of \$5,000, thus meeting the definition of "candidate" per Federal Election Campaign Laws.
