The Friends of Kelly Ayotte committee (FEC ID: C00464297) is in receipt of your letter dated June 1, 2011 with respect to the Committee's 2010 Post-General FEC report. Please accept the response below and amended pages to the 2010 Post-General FEC report as our response to your request.

1. The Committee's campaign management software vendor currently does not support entering the original dates of receipts by a joint fundraising committee; therefore, memo text was added to the original report filed on 12/2/2010 that informed the Federal Election Commission that the contributions were received by the joint fundraising committees on or before the General election day. All contributions are correctly designated as disclosed and no contributions were received by the joint fundraising committees after the General election day.

In consideration of your request, the Committee is re-submitting the transfer memo schedules with the original dates of receipts by the joint fundraising committee clearly identified on each page. The Committee has brought this issue to the attention of the Committee's software vendor for further action.

2. As explained during the teleconference on this matter, the Committee did not submit a duplicate 48-hour notice report. On 11/30/2010, the Committee informed the Secretary of the Senate that when the Secretary of the Senate posted the original report filed on 10/16/2010, their office had inadvertently omitted the 2nd page of the original filing. The Secretary of the Senate corrected this oversight by re-posting the complete report in its entirety. 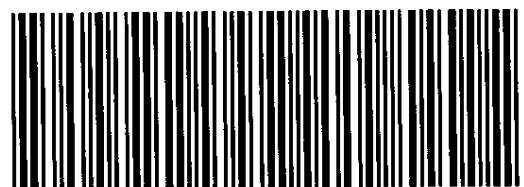
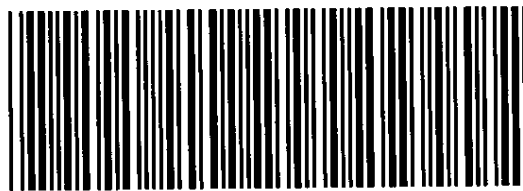
