Since a PO Box is not allowed for a Federal IRS EIN I cannot open bank account yet. I wrote a check for filing fee from my personal account which is from a national affiliated bank (N.A.) but it is not the campaign account. I can receive faxes from FedEx Office if notified (if needed before an office is setup). Funding for running was obtained on Dec. 5, 2019 (which is a personal candidate tax refund which was not expected to arrive before state filing deadline).... I then left for Austin overnight and filed with the Party Friday Dec. 6 (with Texas Sec. of State lawyer from phone call explained required address which for that using nearest closest relative as per my drivers license was allowable but I assume may still not be appropriate for finalizing filing with FEC and bank which I am working on now as I live out of SUV and hotels - as no records to examine would be at someone else's address). Previous campaign was for 2006 election of Texas US Senator at same PO Box 52244 which I have been using as personal po box since regaining control of it. A text message to my phone I can get as long as I renew my monthly prepaid in time. The bank city may change to another depending on when one is opened. The candidate is sole funds provider until a committee bank account is established and then like in 2006 I ended up being the only source of funding with no outside donations as I asked for those to donate to Children's Homes on campaign website. No outside funding is expected for a while until the Primary is won or closer.
