Re.: Resignation as Campaign Manager of Stan Jagla for Congress

Dear Stan:

It is with great regret that effective today, I must resign my position as Campaign Manager and Custodian of Records for your political committee known as "Stan Jagla for Congress," FEC ID no. C00439786.

In doing so, I have followed the suggestions I received by phone today from the FEC person, Rebecca Hough, who is knowledgeable about the FEC record of your committee (see my enclosed letter to the FEC). She said you would have ten days to submit a new Statement of Organization Form 1.

It is simply not possible, Stan, for me to continue being responsible for the wide range of activities that would be required, in my considered judgment, to make your campaign for Congress viable and effective.

As of today, we must consider terminated any and all agreements for campaign management services we entered into on September 12th, or at other times, between you as candidate for Congress and Max J. Havlick as an individual, and between you as candidate and my company, New World Community Enterprises, Inc.

I would be glad, however, to continue giving you my political and consulting advice on a weekly or other regular basis, but we need to discuss that possibility as a separate matter.

I return to you under separate cover all your petitions (signed or unsigned), the file of procedures for filing the petitions, and any other of your campaign literature I still have.

Thank you for the time we spent together, and best wishes in your continuing effort to make a strong statement in the political arena.
