Dear Mr. Furman,

This statement is in response to the Commission's letter to the Committee dated February 23, 2020, requesting additional information on three items related to the above-referenced report ("the Original Report").

First, regarding the totals listed in Column B-P on Lines(s) 28(b) and 28(c) of the Original Report's Detailed Summary Pages, the Committee has corrected these totals on the newly amended version of the 2019 Year-End Report being filed concurrently with this response ("the Amended Report").

Second, the difference between the amount transferred from Trump Make America Great Again (C00618371) and the individual memo entries supporting the transfer constitute unitemized contributions. To the best of the Committee's knowledge, none of the unitemized contributors exceeded \$200 in aggregate for the election cycle. The Committee conducts continued and routine donor record maintenance. If during this routine record donor maintenance, the Committee identifies and merges the records of duplicate donors to reflect proper aggregates, the Committee will amend its report.

Third, the Commission's letter requests clarification on contributions from 442 contributors disclosed on the Original Report that appear to exceed federal contribution limits. All of the listed contributions were properly and timely redesignated, reattributed, refunded/charged back, or returned to a joint fundraising committee ("JFC") in which the Committee participates for proper reallocation, as reflected on either (as appropriate) the Amended Report or the Committee's upcoming 2020 April Monthly Report:

- 167 of the listed contributors' contributions were redesignated to another election.
- 15 of the listed contributors' contributions were either refunded or charged back to the contributor's credit card.
- 224 of the listed contributors' contributions were made by contributors who had contributed to the Committee but subsequently made additional contributions to either Trump Victory (C00618389) or Trump Make America Great Again Committee (C00618371) JFCs in which the Committee participates which distributed the contributions to the Committee. Any funds received through a JFC distribution that resulted in an excessive contribution have been returned to the JFC for reallocation among participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The reallocations will be disclosed by the relevant JFC on the appropriate report.
- 36 of the listed contributors' contributions were in part (i) redesignated to another election and (ii) either (a) refunded or (b) returned to the JFC that transferred the contributions to the Committee to be reallocated by that JFC among its participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The refunds or reallocations will be disclosed by the relevant committee on the appropriate report.
