The Congressional Leadership Fund's administrative expenses as reported on line 21(b) fall into two areas: cash expenses reported for such items as overnight delivery costs, mail box rental fees, and fund raising fees and commissions; and expenses that are donated in-kind by the Committee's treasurer, Charles DeVore. The Committee's treasurer charges the Committee an equivalent hourly rate of \$100 an hour which is then donated in-kind. This rate is fully loaded; that is, the rate includes minor items such as office space rent, computer and email usage, and telephone and fax expenses, as well as professional labor costs, which constitute the bulk of the \$100 per hour nominal rate.
