
I am writing in response to the enclosed letter that you sent to the Committee asking it to disclose the name of its funds depository.

To date, the Committee has not obtained a bank account because it has not raised any money and therefore, has no funds to deposit. Additionally, I have decided to withdraw from the election for which the Committee was formed. The Committee has ceased all campaign activities without crossing the \$5,000 reporting threshold. Therefore, I ask that you terminate the Committee as soon as possible.

As directed in our telephone conversation earlier today, the Committee will not file an amended FEC Form 1, nor will it file an FEC Form 3 for the quarter ending September 30, 2009, as there are no fundraising activities to report.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following items:

You have failed to designate a depository on your Statement of Organization (FEC FORM 1). Commission Regulations require that each political committee discloses the name of its campaign depository or depositories (State banks, federally chartered depository institutions or depository institutions the depositor accounts of which are insured). Please amend (electronically) your Statement of Organization to disclose all committee depositories. (11 CFR § 102.2(a)(1)(vi))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. If you should have any
