Dear Mr. Young:

In response to your letter of Feb. 16, 1999, I am submitting three amended reports--12-day pre-general, 30-day post general and year-end—and the following explanations:

With respect to Summary and Detailed Summary Page figures, I have corrected all mathematical errors and provided corrected (amended) reports.

With respect to failure to include a last minute contribution on the subsequent Schedule A, the explanation is that Drive Political Fund was included in a 48-hour notice for a \$5,000 contribution but when that contribution was recorded on schedule A of the 30-day post general, the contribution was transcribed as \$500, not the correct \$5,000. This is been corrected in the amended report.

With respect to Column A, Line 6 (a) on the Summary report equaling Column A, Line 11(e) on the Detailed Summary page, this error has been corrected.

With respect to failure to file a 48-hour notice, in the case of a contribution from the Sheet Metal Workers International Association PAC, the fact is that the date was incorrectly transcribed. In fact that contribution was received and deposited on 11/5/98, which was beyond the 48-hour notice period. The date has been corrected on the amended report.

I trust these reports and this letter respond to the points you have raised.
