Dear Ms. Hannan:

This letter is in response to your request for additional information, dated August 31, 2010.

1. Your letter indicates that Schedule A of the above referenced reports lists contributions that appear to exceed the limits set forth in the Act.
 - 1) Dennis Fioravanti—refunded in September. This will be disclosed on the October 15, 2010 Quarterly Filing
 - 2) Rob/Robert Freres—these are actually two separate individuals. The July Quarterly Report has been amended to disclose the June 28, 2010 contribution from Robert Freres Sr. There was no excessive contribution.
 - 3) Elinor Hight was refunded \$250 on 8/23/10. This will be disclosed on the October 15, 2010 Quarterly Report.
 - 4) William Moshofsky--\$200 was reattributed to his spouse, Dorothy. This is not itemized on the amended report because her aggregate is under the reporting threshold.
 - 5) Kay Olsen--\$2400 was designated to Primary Debt and \$200 was refunded in June. However, the refund is not itemized on this report as it falls below the reporting threshold.
 - 6) Louisa Spencer—this is actually two separate people. The above referenced report has been amended to disclose the 6/28/10 contribution from Louisa D. Spencer. There was no excessive contribution.

The Committee is well aware of the contribution limits and has either sent letters for presumptive reattributions and redesignations, requested reattributions where required, or refunded the excessive portion of the contribution with in the 60-day time limit.

2. Your letter indicates that the above referenced report discloses contributions designated for the Primary after the date of the Primary. All such contributions are noted as debt retirement. In addition, the above referenced report has been amended to correctly identify loans from the candidate made in February and March of 2010 as loans to the Primary. When the Committee converted its database from the FEC filing software to Complete Campaigns, the loans did not covert correctly and were inadvertently reported as loans to the General (when they were originally reported as loans to the Primary on the April 15, 2010 Quarterly Report). The Committee does have debt and is therefore permitted to continue raising funds to retire that debt until the debt has been satisfied.

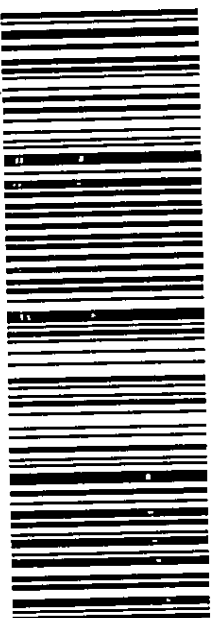
