This Committee responds to the August 9, 2016 RFAI, with response due September 13, 2016, as follows: 1. The Committee exercises its best efforts to report the complete identification of all contributors whose contributions aggregate in excess of \$200 in a calendar year. First, all solicitations include a clear and conspicuous request for the required contributor information and a disclaimer informing the contributor of the requirements of federal law for reporting such information. When contributions are solicited online, the online donation page requires all contributors to provide their employer and occupation in order to submit a contribution to the Committee. Second, where a contributor has not provided all information or provided inadequate information, Committee policy is to communicate with all such contributors, at any dollar amount, via mail, to request the missing information. This request is not made in the form of a solicitation, and explains to the contributor that to comply with federal election law, the Committee is required to make its best efforts to obtain and report each contributor's name, address, name of employer and occupation. Third, if the contributor responds and provides the requested information, it is added to the contributor's record in the Committee's filing software and reported on the next regularly scheduled FEC Report, or an appropriate amendment is filed to a prior report. The text added to the report when name of employer and/or occupation information is missing is a placeholder used to indicate that this best efforts process is properly underway. At this time, the Committee has not received any additional information for the report at issue. 2. With respect to the three independent expenditures identified, the item at issue on the report received 5/13/16 was, as indicated on the report, originally budgeted for substantially less than the \$10,000 reporting threshold, but the voter contact campaign was more successful than anticipated. Once the Committee received an invoice from the vendor indicating the increased cost, it filed a report including the amount spent so far, and estimates for the remainder of the month more in line with the campaign's performance. The second expenditure, from the report received 6/8/16, was a late-arriving invoice thought to have been accounted for in the other expenditures disclosed on the original 48-hour report. Once the Committee received the invoice and determined that amount was separate from the amounts previously disclosed, it filed an amendment disclosing the expenditure. The third expenditure, from the report received 6/13/16, was part of the estimate filed 5/13/16, along with the first expenditure at issue above. An amendment to that report was filed on 6/6/16 to update the estimates with final expenditure figures, and included a payment to the vendor for this expenditure, but after that amendment had been filed, the vendor submitted another invoice for May voter contact services - the amount at issue here. Accordingly, an additional amendment was filed to include that amount in the final expenditure figures. This amount and the other amount reported to the vendor on the first amendment were both properly and timely disclosed in the initial estimate filed 5/13/16. 3. The expenditures at issue on Schedule E were not targeted at any particular state or set of states, except where expressly indicated. Instead, these were distributed nationally, with the goal of influencing the outcome of the 2016 GOP National Nominating Convention. Consistent with that goal, and with the Commission's proposed interpretive rules on reporting nationwide independent expenditures in presidential primary elections, the Committee reported these expenditures as being for the Convention, and not, as would be factually incorrect, for one or more states. Since none of the expenditures at issue were targeted at any particular state or set of
