The National Football League provided 35.75 hours of professional staff time (valued at approximately \$5,022.81) in this reporting period with respect to PAC activities such as fundraising and decision making about contributions. In addition, the National Football League provided 16.1 hours of administrative staff time (valued at approximately \$365.00) in this reporting period with respect to PAC activities such as fundraising and decision making about contributions. All of the services, with respect to PAC activities such as fundraising and decision making about contributions, that the National Football League donated to the PAC for the period of January 1, 2017 through June 30, 2017 took place from January 4, 2017 through June 27, 2017.

On November 7, 2016, Gridiron-PAC made a \$5,000 prepayment to the National Football League to offset potential staff time in excess of \$5,000. This prepayment was reported on Schedule B of the 30 Day Post-General 2016 report (Transaction ID SB21B.8581). The total funds retained by NFL as of December 31, 2016 was \$3,633.12. In this reporting period, the prepayment is used to offset \$387.81 in additional federal operating expenditures. The total funds retained by NFL as of June 30, 2017 is \$3,245.31.
