1. Please amend Schedule B supporting Line 23 by providing the congressional district, if applicable, for each contribution made. 11 CFR §104.3(b)(3)(ii) and (v)
2. Schedule B supporting Line 23 of your report discloses a contribution to an apparent "leadership" political action committees, "Harvest PAC;" however, you have also disclosed the name of "F. Allen Boyd" in the candidate name field. Please clarify whether this was an earmarked contribution made by your committee through "Harvest PAC" to this candidate, or if you made this contribution to the political committee exercising no direction or control over how the funds were to be used. If the latter is the case, please only include the name of the apparent leadership PAC on Schedule B. Please amend your report to clarify the ultimate recipient of this contribution.


