All disbursements that are reported administrative and reported on H4 are not in connection with a federal candidate or a federal election. Salaries paid on the administrative split and reported on H4 are for employees who spend less than 25% of their work hours on federal election activity. All payments for payroll, payroll taxes and insurance that are reported as administrative on H4 are not paid on behalf of employees who spend more than 25% of their work time on federal election activity. Salaries reported on line 30b are for employees who spend more than 25% of their work hours on federal election activity. All payments for payroll, payroll taxes and insurance that are reported on 30b are paid on behalf of employees who spend more than 25% of their work hours on federal election activity. Currently the committee does not have any employees who meet the threshold for over 25% FEA. The DSCC of LA participates in the State Democratic Party Victory Fund and Dollars for Democrats joint fundraising programs. Transfers of proceeds are made to the DSCC of LA on an as-needed basis. Please note that state party committees have been reporting Memo Entries on Schedule A for contributions received by the joint fundraising program during the reporting period in which the contribution was received irrespective of whether transfers have been made. Memo Entries on Schedule A from these programs reflect the gross amounts raised while the transfers to the DSCC of LA reflect the net amount distributed to date. Accordingly, there will always be a difference between the transfer and the Memo Schedule A totals. By prior agreement between the DSCC of LA's counsel and the FEC, Memo Schedule A's for these programs are reported on a quarterly basis. Please note the Louisiana Democratic Party owns its own building and therefore does not make regular rent payments.
