I also have one request. Your rule books on campaign financing are helpful and accurate. But, you need a book covering the first twenty-five points of becoming a candidate. Whereas if a possible candidate could follow a point by point system, it would be most helpful. Especially a person who wants to become a candidate or for students who need to know the systematic process candidates have to go through.

It may also be helpful legally, when chastising candidates who have broken the rules via their ignorant legal assistants. If a candidate received this twenty-five point system, and had to personally read, comprehend and return a copy of it signed and dated, it would be a valid stop to early candidate failures for legal mistakes.
