Ms. Chacona,

I filed my report of all donations last year, which included the period 4/1/24 to 6/30/24 on July 23, 2024. See receipt on back of this letter.

I stopped accepting donations when my campaign ended with the Mar 19 2024 primary.

As I understand it- when you don't take in over \$5000, you don't have to file.

The fact is, your filing system is a complete tech fail. The inability to file with a Mac, the requirement of a PC executable file to transform industry standard CSV files to some funky format is a travesty and not ADA compliant by any means.

That it can't be accomplished online like EVERY OTHER FILING SYSTEM used by EVERY STATE in the UNION makes your organization a laughing stock of the world.

That America requires voters to register, but lets candidates self-report donors is criminal and leads to your data being a joke. Many candidates file and say that ActBlue or WinRed was their donor- or that a billionaire baseball team owner with the initials SAC can show up as different people- Steve, Steven, Stephen, at multiple addresses shows the absolute incompetence of your organization and its failure to do its job.

Right now, Husted for Senate lists 256 donations from someone named WINRED who gave \$468,229.18

Please, do your job. Or, take me to court. I'm sure a jury would LOVE to have you explain this.

Which comes to your last statement, about my email, Treasurer@electesrati.com not working. It works fine, your email server and the DOJ's court email server has some kind of block on emails going to domains protected by Cloudflare- an American company that provides content delivery network services, cloud cybersecurity, DDoS mitigation, wide area network services, Domain Name Service, and ICANN-accredited domain registration services. For some reason, only these two Federal domains seem to have a problem with our email configuration. Try using gmail or have your IT folks look into it.

May I also add that your entire system requiring candidates to set up EIN's, bank accounts, and campaign donation websites and self reporting could easily be offered by the FEC in a user friendly way that provides real time reporting, by just providing a single donation portal, with real donor verification, and distribution of funds through a debit card and a single point payroll platform for all political work. If you need help with this, I have a 501c3 called "The Modern Policy Institute"- www.modernpolicy.org that would be more than happy to help and guide the FEC into the 21st century. The open source software, CiviCRM could do most of the heavy lifting for you- and work perfectly well. 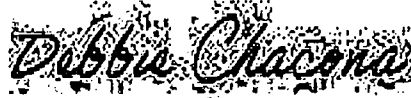

Please note that electronic filers must submit their reports electronically, as per 11 CFR §104.18. A copy of the report must also be filed with the Secretary of State or equivalent State officer unless the State is exempt from the federal requirement to receive and maintain paper copies. You can verify the Commission's receipt of any documents submitted by your committee on the FEC website at www.fec.gov.

The failure to timely file a complete report may result in civil money penalties, an audit or legal enforcement action. The civil money penalty calculation for late reports does not include a grace period and begins on the day following the due date for the report. The Commission recommends that you submit your report via overnight delivery or courier service.

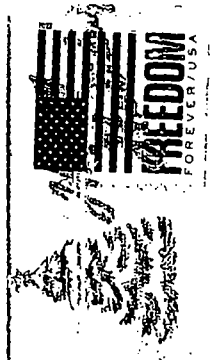
