To Whom It May Concern:

This correspondence issues on behalf of Amish PAC, a non-connected committee that first registered with the Commission on April 20, 2016. Consistent with the stipulated judgment in *Carey v. FEC*, this Committee intends to establish a separate bank account ("non-contribution account") to deposit and withdraw funds raised in unlimited amounts from individuals, corporations, labor organizations, and/or other political committees. The funds maintained in this separate account will not be used to make contributions, whether direct, in-kind, or via coordinated communications, or coordinated expenditures, to federal candidates or committees.

The Committee will maintain its existing bank account to deposit and withdraw funds in conjunction with the requirements and limits of the Federal Election Campaign Act and its associated regulations. The funds maintained in this "contribution account" will continue to be used to make contributions – whether direct, in-kind, or via coordinated communications, or coordinated expenditures – to federal candidates and committees.
