It is my sincere hope that these amended forms will clear up any discrepancies that were created. I will work diligently with the FEC to ensure my campaign is within the guidelines.

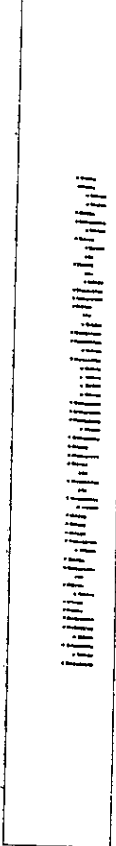
