This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Line 5(d) indicates that your committee is a subordinate committee of the Democratic Party. In Line 6, however, it appears that you inadvertently indicated a Membership Organization. This designation is reserved only for Connected Organizations operating separate segregated funds. A party committee would not check these boxes, even if it is composed of members. The Commission's definition of Membership Organization can be found at 11 CFR §114.1(e).

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
