Dear Sir:

I am enclosing my two applications: (FEC FORM 1) – STATEMENT OF ORGANIZATION, and (FEC FORM 2) - STATEMENT OF CANDIDACY, both dated 25 June 2016, for the purpose of running for the U.S. PRESIDENCY this year of 2016 on the Republican ticket.

I am starting at a 'ground zero' level position in this pursuit. I am living on disability, by God's grace, and my car is broke down (no money to fix it). For a few months I was without the use of a phone. I do not even qualify for a \$100.00 loan from the bank. I have never run for any political office before either. I am, totally, new at this. My finances are the pits.

I do have a story to tell. I hope to write a book someday about my personal testimony that this nation has to hear. I am trying to start a business, and am strapped to using whatever limited finances I have to develop all the products that God has blessed me with the idea to create, and eventually sell. I can only do so much, and am trying to be a good steward in the limited finances I am living on. I have no financial support from any group here locally, or statewide. I am a new kid on the block, so to speak, and the citizens here, in this local community, are not in any financial position to help me, and most do not know of my intent to run for the presidency. I have been keeping quiet for the most part.

BUT, after all the personal hell I have suffered for years, in more ways than one, it was in the evening of 11 August 2014, during my prayer time, that God revealed to me, for the VERY FIRST TIME that He was calling me to run for the United States Presidency on the Republican ticket in 2016. All I could do was weep, and weep, and weep before Him. I

It is God Who is calling me to run. And I am willing to obey Him in this divine call. He is not playing games with me, and I am not playing any games with anyone here either. And it will be to God's glory when I win, God willing, this election, as well. I am the least of all brethren. And His strength is made perfect in my weakness. And I am a God-fearing woman, with deep convictions. I am 61 years of age. And it is by God's grace during all of my life, I exercise a drug-free lifestyle; an alcohol-free lifestyle; and a nicotine-free lifestyle. I have a clean criminal record; and a clean driving record. I am a born-again, spirit-filled Christian. The devil hates my guts, and I hate his. So, needless to say, God allowed him to attack me in various ways in my life. Little did I know, that God was bringing me through a boot camp of sorts all these years in preparing me for this call to be the 45th President of U.S. I had no idea what He, ultimately, had planned for me in my future. 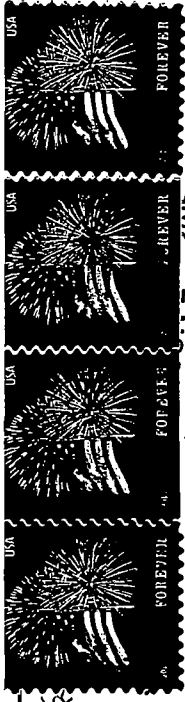


