Please find attached an amended Form 1, Statement of Organization, and Form 3X, Report of Receipts and Disbursements, a termination Report for this period.

Our organization received a letter from you dated March 24, 2004, requesting that our relationship with the MCI Employee PAC be clarified, and ultimately, a new Statement of Organization be filed.

The MCI WorldCom, Inc. Ohio Employee PAC CP1044 is affiliated with the MCI WorldCom, Inc. Employee PAC, and it is connected with MCI WorldCom, Inc. I have amended that information on the Form 1 to reflect those relationships.

Also, our organization has re-filed a Form 3X, requesting termination of our FEC registration. The MCI WorldCom, Inc. Ohio Employee PAC CP1044 typically makes contributions on a state level only, however, in October, 2003, a contribution was made to a federal candidate. On 10/24/03, a check payable to Bush-Cheney '04 in the amount of \$2,000 was issued for a fundraising event sponsored by Ohio Governor Taft. Our organization does not plan to make any more contributions to candidates running for federal office.
