
Dear Mr. Andre:



This is a follow-up to our telephone conversation. Due to an inadvertent oversight, the America First PAC was not an official multi-candidate PAC back in January 1992.

This means that the \$4000 contribution America First PAC made to the Buchanan for President campaign was in excess of legal limits. In order to comply with FEC requirements, the Buchanan campaign for President 1992 must refund \$3000 to America First PAC.
