
This letter is in reference to the letter (RQ-5) that I received concerning an adequate response concerning my Principal Campaign Committee.

Please contact me the undersigned should you have any questions or concerns.

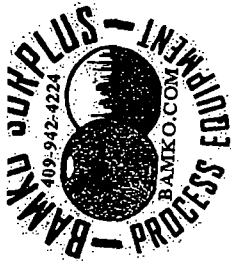

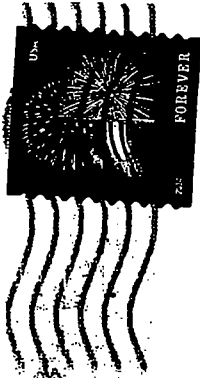
