The Independent Expenditure was originally estimated for \$25,000. The Committee incorrectly amended this Independent Expenditure to reflect one of the vendor invoices but failed to include the remaining estimate amount. This current amendment adds the remaining invoices paid and is the final amount. (Prior Memo Text) Prior to receiving a committee ID and electronic filing password, this Committee made independent expenditures subject to 24-hour reporting requirements. In order to properly disclose this activity, the Committee filed a Form 5 (FEC-1041979) using the Commission's online filing system. The expenditures disclosed on FEC-1041979 were for nationally distributed communications not targeted at any particular state or set of states. Consistent with the Commission's proposed interpretive rules on reporting nationwide independent expenditures in presidential primary elections, the Committee reported these expenditures as being for the national nominating convention. Due to limitations in the online filing system, the Committee was unable to include memo text detailing this on the original reports.
