2. PROMISE TO PAY

For value received, the Borrower, **Friends of Whitfield Harrington** (the "Committee"), promises to pay to the order of the Lender, **Whitfield Harrington** (the "Candidate"), the principal sum of **Ten Thousand Dollars and Zero Cents (\$10,000.00)**.

This loan is made from the personal funds of the Candidate to the Candidate's authorized principal campaign committee for the purpose of influencing the Candidate's election for federal office, in accordance with Federal Election Commission (FEC) regulations (11 CFR 100.33 and 110.10).

3. INTEREST

This Note shall bear interest at the rate of **zero percent (0%)** per annum.

4. REPAYMENT

The entire principal balance of this Note shall become due and payable in full on or before **July 1, 2026** (the "Due Date"). The Borrower may prepay all or any part of the principal amount of this Note at any time without penalty.

Repayment of this loan is subject to the availability of campaign funds and the restrictions set forth in the Federal Election Campaign Act and FEC regulations, including but not limited to the restrictions on the repayment of candidate personal loans exceeding \$250,000 (11 CFR 116.11 and 116.12).

5. FORGIVENESS OF DEBT

The Lender reserves the right to forgive all or any portion of the outstanding principal balance of this loan at any time. Any such forgiveness shall be documented in writing, signed by the Lender, and reported by the Borrower as a contribution from the Candidate on the appropriate FEC reports.


6. REPORTING REQUIREMENTS


