Dear Ms. Clark:

I am the Treasurer of CLARKPAC of Clark Consulting ("CP"). On March 19, 2007, the connected organization of CP, Clark Consulting, was sold. The majority of the business units were merged into another corporation. The administrative functions and several business units of Clark Consulting were spun off to Clark & Wamberg, LLC. On March 19, 2007, I filed an amended Statement of Organization, FEC Form 1. Attached is copy of that form.

At the time of the sale of Clark Consulting, I mistakenly believed that Clark & Wamberg LLC would be a corporation and could serve as a connected organization. Subsequently, I learned that Clark & Wamberg LLC elected to be treated for tax purposes as a partnership.

The first payroll run of Clark & Wamberg LLC occurred on April 6, 2007. PAC contributions were deducted for the following 12 employees in the amounts shown below.


