This submission is tendered in response to the Federal Election Commission's Request for Additional Information (RFAl) dated March 25, 2026, pertaining to the Committee's 12 DAY PRE-PRIMARY REPORT (01/01/2026 - 02/11/2026). The Committee hereby affirms that each contribution identified in the Commission's RFAl has been addressed in strict conformity with the requirements of the Federal Election Campaign Act and the Commission's implementing regulations. All corrective measures - including refunds, redesignations, and reattributions - have been, or will be, effectuated within sixty (60) days of the date of receipt of the contribution, as prescribed by and in compliance with 11 C.F.R. §§ 103.3(b), 110.1(b)(5), and 110.1(k)(3).
